The permit conditions are as follows:

- 1. Testing to be performed in the right-of-way or crossing the right-of-way of County Road at the location shown on the attached map (see attached). If more than one road is involved, please attach a list.
- 2. Testing to be performed in accordance with "Additional Permit Conditions", attached hereto as "Attachment A".
- 3. The Applicant shall obtain written permission from all property owners involved and copies shall be attached. Permission to cross the County Road (s) or be within the County right-of-way is hereby granted where the property owner has granted the same.
- 4. No excavation, drilling or blasting will be permitted within the County rights-of-way.
- 5. The Applicant shall maintain traffic at all times. All warning signs, barricades, flagpersons, etc., needed to protect traffic at all times during the testing, will be furnished by the Applicant and conform to OMUTCD (Ohio Manual Uniform Traffic Control Devices). Cones shall be placed around any stationary vehicles. Cones shall be placed every 500 feet. No work shall be done before sunrise or after sunset. No work shall be performed on Sundays.
- 6. No permission is granted to exceed the posted load limits on any bridges on the route selected. No permission is granted to vibrate within 50 feet of a bridge or other similar structure. Any damage caused by the testing to the roadway will be repaired by the Applicant and to the full satisfaction of the Morrow County Engineer.

7. The Morrow County Engineer's Office shall be notified at least 24 hours prior to starting work or movement. 8. The County of Morrow shall be saved harmless from any and all claims for any and all damages which may be caused or as a result of this work being performed within the Morrow County Road right-of-way. A current certificate or binder for property and liability insurance shall be attached as "Attachment B" and made part of this permit. 9. I hereby certify that I will abide by all terms, conditions, restrictions and regulations of the Morrow County Engineer's Office/Morrow County Commissioners as stated. Additional Conditions:

- 1. No explosives to be used within the road right-of-way.
- 2. Crew will carry permit and contact information.
- 3. Trucks to be clearly marked with company name.
- 4. No work to be done during normal frost law March, April, and May without written authorization from the Morrow County Engineer.
- 5. Permit to allow vibrator truck and recording truck to operate in the road right-of-way.
- 6. Liability Insurance \$2 Million BI/PD, \$1 Million Auto and \$4 Million umbrella coverage.
- 7. Morrow County to be added as additional insured or an active certificate of insurance filed with each permit.
- 8. Permit holder to notify the Morrow County Engineer in a timely manner when work will begin in order to allow for pre-inspection, random, and post inspection.
- 9. All permits to be signed by the Morrow County Engineer.
